

Terms and Conditions – Mentoring & Coaching Agreement (Page 1 / 2)

This is an agreement between Leah Black the “Mentor/Coach” and the “Client” who is the person receiving 1-2-1 sessions by Leah Black “Mentor/Coach” and whom is agreeing to and signing this agreement. **Please**

note: Ecoinner sense utilises an intuitive, other-centred approach and provides services including but not limited to Nature Mysticism Mentorships, Nature Communication, Natural Mindfulness, Mystical Nature Writing, Soul Purpose Coaching, Green Tarot and Nature Oracle etc. and these will likely involve outdoor activities and exercises. The Mentor/Coach takes absolutely no responsibility for your health and safety, accidents or injuries when completing any outdoor or indoor exercises or activities, or when travelling for them.

- By signing this agreement, the Client consents to being 18 years old or above.
- As a member of EMCC, Leah Black follows the EMCC Global Code of Ethics: <https://www.globalcodeofethics.org/download-the-code/> that the Client is encouraged to read for information on Coaching and coaching and mentoring ethics. - As Coaching and Mentoring differ, Leah Black will clearly define between them when mentoring is requested or deemed more appropriate. This will be agreed with the Client verbally during a session.
- The Client is not permitted to record sessions.
- The Mentor/Coach does not, normally, take detailed session notes. It’s important for the Client to keep their own notes if they wish to.
- Full payment of each session/package must be made upfront and is absolutely **NON-REFUNDABLE**. Fees and payment procedures will be clearly stated in the Client’s quote and invoice. The Client must meet the Mentor/Coach for a free consultation to ensure Ecoinner sense services are the right match for you before paying.
- For privately tailored training, consultancy, talks, retreats and workshops, a quote can be requested after an initial consultation is carried out.
- The Mentor/Coach holds absolutely NO responsibility for the career, relationships, life, decisions or actions of the Client, nor the physical or psychological health of the Client.
- The Mentor/Coach is not liable for ANY losses by the Client; including but not limited to loss of profit, loss of finances, loss of business, loss of property or assets or breakdown of relationships.
- The Client holds the Mentor/Coach completely harmless from the consequences of any actions carried out because of anything said between the Mentor/Coach and the Client. Anything the Mentor/Coach says should not be taken as ultimate advice. - The Client represents and warrants that they are psychologically well enough to receive Ecoinner sense sessions and will NOT hold the Mentor/Coach liable for any pre-existing medical or psychological health problems and the Client hereby receives the sessions at their own risk.
- Sometimes Ecoinner sense isn’t the right support for a Client. If the Mentor/Coach feels, at any point, that a different type of support is necessary, the Mentor/Coach may end the sessions with the Client and suggest that they are referred to another a service like counselling for example. In this instance a refund for unused sessions will be given.

- The Mentor/Coach's approach to tarot and oracle cards is to invite us to read and reflect on the cards together. This is not fortune telling and the Mentor/Coach does not predict the future. The Mentor/Coach must legally inform you that any engagement with Tarot or Oracle cards is for entertainment purposes only.
- The Client should NOT contact the Mentor/Coach about personal issues, or emergencies, in-between sessions.
- The Mentor/Coach reserves the right to end sessions with the Client if they feel that the sessions are, for whatever reason, unhelpful for the Client.
- The Mentor/Coach also reserves the right to cancel sessions if the Client is deemed to be abusive towards the Mentor/Coach in any way or an incorrect match.
- The Mentor/Coach adheres to GDPR regulations and confidentiality laws, as laid out in the Coach's '**Privacy Policy**', and holds the Client's information in the strictest of confidence, unless release is required by law for significant reasons such as child protection and safeguarding, a Duty to Warn if a Client is a serious threat to themselves or others or reporting of illegal activity. The Mentor/Coach shares basic information, as required by law, e.g. for accounting reasons.
- The Mentor/Coach may share your full name and email address for reporting coaching hours for accreditation, or renewal of accreditation, with professional Coaching bodies. The professional bodies the Coach may share your name and email address with are The European Coaching and Coaching Council (EMCC): <https://www.emccglobal.org> and ICF <https://coachfederation.org>. These professional coaching bodies may carry out an audit and contact you to confirm that you have been a client of Leah Black. By signing this agreement, you consent for this information to be shared with EMCC and ICF, for the purposes aforementioned.
- By signing this agreement, you confirm that you've read, and understood, the Mentor/Coach's '**Privacy Policy**' that is freely available for download, situated in the footer, on the Mentor/Coach's website: <https://ecoinnersense.com>. The 'Privacy Policy' outlines how your personal data will be stored, processed, shared, retained and used.
- The Mentor/Coach's Clients, and visitors to Leah Black's website, do not have permission to copy, share, duplicate or disseminate the Mentor/Coach's resources, activities, worksheets, wording in any documents or website, Coaching and training content.
- The Client agrees not to copy, use or share the Mentor/Coach's intellectual property or materials with others.
- In circumstances beyond control e.g. sickness, the Client and the Mentor/Coach may cancel a session by providing a minimum of 3-hours' notice of cancellation before the session is due to start. If 3-hours' notice is not given, the Client will be charged for their missed session. - The Client and the Mentor/Coach agree to be on time for each of the sessions and not under the influence of mind-altering substances such as drugs, strong medication or alcohol.
- These terms and conditions may change and get updated from time to time. If the Client renews sessions, they will be informed of any changes and requested to sign an updated agreement.
- Agreeing to this form does NOT guarantee an offer of Ecoinner sense services with Leah Black. To secure sessions the Client must make a payment as per the conditions laid out in the Mentor/Coach's invoice.
